APPLICATION PROCESS

SHUR-GRIP can be used in most sealers and coatings where increased slip resistance is desired. SHUR-GRIP can be used indoors or outdoors, especially over decorative concrete surfaces where other non-skid materials can not be used because of their color.

Procedure – Mix sealer or coating to proper consistency. Slowly add prescribed amount of SHUR-GRIP and remix until properly dispersed. Apply sealer or coating as directed without over rolling. SHUR-GRIP is fine enough that it can also be used in most spray applications.
